#### **SECTION 7 - HANDLING AND STORAGE**

**7.1 Precautions for safe handling:** Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing. Avoid the formation of dust and aerosols. Use in a well-ventilated area. Keep away from sources of ignition. Avoid prolonged or repeated exposure.

**7.2 Conditions for safe storage, including any incompatibilities:** Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Store the sealed bottle containing the dehydrated medium at 2 - 30°C. Once opened and recapped, place the container in a low humidity environment at the same storage temperature. Protect it from moisture and light. The dehydrated medium should be discarded if it is no longer free flowing, or if the color has changed.
