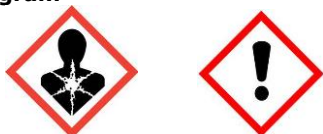

4.1 Description of first aid measures

5.2 Special hazards arising from the substance or mixture: Carbon oxides, Nitrogen oxides (NOx), Hydrogen bromide gas.

SECTION 6 - ACCIDENTAL RELEASE MEASURES
